

## **Interdisciplinary comparative analysis of the complex system of Abkhazian conflict via innovative 4D-RAV-17 method**

### **Abstract**

The scientific mission of the Abkhazology is to merge various scientific directions for the well-being of Abkhazia and Abkhazians.

Possibilities of science were insufficiently used in the management of such a problem, including the unsolved Abkhazian conflict.

This conflict is truly "worth" to become one of the main object of Abkhazology studies.

The situation is complicated by the fact that Abkhazology itself is one of the arenas of the Abkhazian conflict today. This is a real threat to the peace process. Science should serve peace and not conflict.

It is important to involve scientists-Abkhazologies in the diagnosis, planning and development of the new peace process. The cooperation of science for peace is - the basis of academic, scientific and university diplomacy.

Is one of the modest attempts to fulfill this mission.

The goal of the project is to facilitate the positive transformation of the Complex System of Abkhazian Conflict through the innovative 4D-RAV-17 copyright research method.

The research object is "the Complex System of the Abkhazian conflict" (CSAC). It contains - the existing conflict; new generative real conflicts and unrealistic (pseudo-conflicts) produced from him; quasi-peace and peace processes.

This concept deals with new tool that will destroy harmful stereotypes that prevent adequate scientific diagnosis. Therefore, the first value of the project should be a scientific result – (CSAC) "Scientific diagnosis of the Complex System of the Abkhazian conflict".

This diagnosis can be found in the redundancy and cholic point of scientific thinking. We chose a cholic approach to a simple goal. This reason consists in the fact that for the main

psychological reasoning of the conflict resolution, we presume the style of redundant thinking and actions.

The complex system of the Abkhazian conflict will be replaced as a result of the reductive understanding and interpretation of its separate components, which is the methodological basis for the inadequate diagnosis. Inadequate diagnosis has been the basis for the creation of pseudo-conflicts and relevant quasi-peace processes. This is the immediate cause of unresolved conflicts.

The research project offers an alternate path - the holistic diagnosis and its relation to the creation of a project of an alternative peace plan.

The project also provides for the creation of "Peace Vocabulary" as a result of psycholinguistic analysis. This will be a new set of terms that will serve the alternative peace process.

The project also regards the use of other innovative scientific technologies and strengthening the alternative peace process.
